Abstract

The length of the abstract should not exceed 300 words. The abstract should appear immediately following the title and the names of authors, and should not repeat information already present in the title. Author should state specifically the contents of the paper without reading the main body. State briefly the subject, methods, equipment, results and discussion of research. A summary leading to conclusions is not required.

Keywords : Three to Five key words should be chosen that best describe the contents of the paper. Capitalize the initial letter of each word. These words will be used for search and retrieval, as well as indexing.

1.0 Guideline for text preparation

The maximum length of an article should be not exceeding 6 A4 pages (single-spaced, 12 Times New Roman) including figures and tables. The quality of English must be sufficient at the time of submission. Text shall start with a concise 'Introduction,' which should be free from unnecessary or non-essential details. Plain and standard English should be used for preparation of the text. It should be divided into sections with clear titles for easier reference. Authors have to either use the spell-checking facility of their word processor or proofread the manuscript themselves before submission of the paper.

2.0 The order of your manuscript

The following order is the recommended structure of a manuscript:

- Introduction (purpose of research, significant of research supported by a literature survey, outline of contents, explanation and others).
- Nomenclature (subscripts)
- Main body of text (theoretical analysis, method, results of experiment, interpretation of results and discussion)
- Conclusion (conclusion obtained through research)
- Acknowledgement
- References

The above order is presented as an example, and authors may select the most suitable and effective style for the contents of their manuscript. Figures and tables should be included in main body text.

3.0 Notations

Symbols should be either defined in the text or entirely placed at the end of the text and immediately before the 'References' section. Symbols cited should be listed alphabetically in the order of Roman symbols, letters, subscripts and superscripts.

4.0 References

References should be listed in numerical order in the order in which they are cited in the text. Use Arabic numerals followed by a period (1., 2., etc.). The numbers must correspond to the ones used for reference within the main text (in brackets: []). Give complete information, including names of all authors, titles of the article and periodicals or books, numbers of pages and volumes, and publication years. Authors should use the following style to format their references:

For Journals:

[1] Author, A. A., and Author, B. B., "Title of Journal," *Name of Journal*, Volume (Issue), Initial page-ending page (Year of Publication).

For Books:

[2] Author, C. C., and Author, D. D., Book Title, Version, Publisher, City of Publication, Initial page-ending page (Year of Publication).

For Conference Proceedings:

[3] Author, D.D., and Author, E.E., "Title of Proceeding," Name of Conference/Symposium Proceeding, City, Country, Initial page-ending page (Year of Publication).
